4. Public participation on Municipality by-laws had taken place in four market centres namely Miruka, Nyabite, Kebirigo and Ting'a. the sentiments captured had been considered and the final drafts forwarded to the cabinet for adoption. It was noted that during the public participation exercise citizens had not been sensitized enough as they were bringing new agendas to the exercise. A member noted that there was need by the municipality to sensitize staff for such events to prevent deviation from the items for discussion. There was need for early dissemination of the items to be discussed to enable citizens go through them before the material day. The Municipality manager was tasked to ensure the Bylaws are submitted to the cabinet and eventually adoption by the county assembly. as evidence on the claims.

## Min 05/19/10/2023: Confirmation of minutes

The meeting was taken through minutes of the previous meeting by the chairman and manager. The minutes were proposed by Ceciliah Ondima and seconded by Margaret Oyaro. A member noted that sharing of minutes with members should be done earlier to enable them prepare well for the meeting.

## Min 05/19/10/2023: Status of projects- KUSP I and KUSP II

The manager informed the meeting that KUSP I was to end on 31st July 2023, but an extension was given to 31st December 2023 for the completion of KUSP I projects, failure to which the Municipality was to lose funds. The manager briefed the members on the status of each of the three projects.

- 1. The 1st project (FY2018/19), i.e., the road from Borabu Junction to Nyabite, had been handed over, and a completion certificate had been issued.
- 2. The second project, i.e., the road from Public Works to Hospital gate drainage works were 50% complete and were to be completed by 31st October 2023. The sidewalk was 60% done and expected to be completed by mid-November 2023. Streetlights had not yet begun but were expected to start at the beginning of November and last for a fortnight. Payment was at 50% of the contracted sum.
- 3. The fire station the contractor had become sluggish. The perimeter walls and borehole had not been completed. Erection of the water tower had yet to start. Painting had been done, while tiling of floors had not started. There were variations that led to the septic tank being funded from their own budget. Board Members requested more information on the project. The infrastructure subcommittee was to have a meeting with H.E Governor on 2nd November 2023. The manager informed the meeting that KUSP II had already started. A meeting between Municipality managers, World bank, and the Council of Governors had
